

UPLOAD YOUR VALID IDS AND TAKE A SELFIE FOR VERIFICATION

- 1. You will need to upload a clear copy of your valid ID, and a "selfie" while holding your valid ID in order to verify your identity.
- 2. Take a photo of the front and back portion (if signature portion appears on this side) of your ID, without flash.
- 3. Capture the image from above, with your ID on a flat surface. Ensure all four corners of your ID are showing.
- 4. Don't crop, rotate, touch up, adjust colors, or alter the images in any way.

With reference to the above-mentioned IDs, furnishing proof of identities either in individual or joint account, the client has the following alternative options:

Options		Proof of Identity to be provided
1	:	Provide at least one (1) PRIMARY ID with at least one (1) year validity, "preferably" non-expiring ID.
2	:	In the absence thereof, provide two (2) PRIMARY IDS at least 6 months validity .
3	:	If both above options cannot be availed, provide at least one (1) PRIMARY with six (6) months validity and one (1) SECONDARY ID.
4	:	If all options cannot be availed of, provide two (2) SECONDARY IDS.

For opening of In-Trust-For (ITF) Trading Account

The Primary Holder which ostensibly called as the trustor is required to provide the following requirements:

- Required IDs with reference to the sample list
- **Notarized ITF Form-** indicating sole ownership upon maturity









Likewise, the minor beneficiary shall submit the following documents to establish the relationship with the primary holder.

- NSO/PSA Birth Certificate
- Student ID if, any

For opening an account with foreigner individuals (Resident/Non-Resident)

- > **For Resident Alien**, please provide a valid passport and any of the following:
 - Valid Alien Certificate of Registration Card (ACR) indicated that he/she is Permanent Immigrant and Native Born
 - Valid Special Resident Retiree's Visa Card (SRRV)
 - Valid Special Investor's Resident Visa Card (SIRV)
 - Certificate of Naturalization
 - Certificate of Dual Citizenship
- **For Non-Resident Alien,** please provide any of the following:
 - Valid Passport
 - Driver's License
 - Certificate of Residency Consularized (Non-Personal Appearance)
